**The Sanitary certificate may be issued subject to the following conditions:**

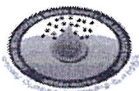
- ❖ The garbage generated within the building premises should be collected and disposed of properly by appointing required sanitary staff.

- ❖ The lab in charge should be well trained in handling the fire extinguisher.
- ❖ No smoking board should be displayed at predominant places with in the premises.
- ❖ No account sale of tobacco products should be permitted within the premises.
- ❖ Any occurrence of communicable disease should be notified to the Public Health Department.
- ❖ One time use and throw plastic is banned strictly by the Tamil Nadu Government. So ensure "Plastic Free" in your premises.

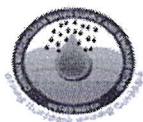
